2021-22 Phase Three: Comprehensive School Improvement Plan Rationale

School improvement efforts are a collaborative process involving multiple stakeholders. During the improvement planning process, leaders focus on priority needs, funding, and closing achievement gaps between identified subgroups of students. When implemented with fidelity, the Comprehensive School Improvement Plan (CSIP) cultivates an environment that promotes student growth and achievement.

While the focus of continuous improvement is student performance, the work must be guided by the aspects of teaching and learning that affect performance. To decrease the gap in reading between P/D of economically disadvantaged vs non-economically disadvantaged students from 28% to 10%. We will do this through continually gathering data such as STAR to make sure we have the appropriate interventions in place. We will also continue to use our FRYSC to provide support to families to help eliminate barriers and increase our communication in regards to student expectation and how parents play a large role in partnering with the school to grow their child. Increase the number of students performing P/D in science from 29.7% to 40%. We will do this by analyzing data at the school level to ensure students are understanding the standards. We will measure the overall success of

the program with State Testing. We will implement a new curriculum for Science 3-6 and will support teachers with training in those areas.

Operational Definitions

Goal: Long-term three- to five-year targets based on the five (5) required school level goals. Elementary/middle schools must have goals for proficiency, separate academic indicator, achievement gap, growth, and transition readiness. High schools must have goals for proficiency, separate academic indicator, achievement gap, graduation rate, and transition readiness.
