2021-22 Phase Three: Comprehensive School Improvement Plan

Rationale

School improvement efforts are a collaborative process involving multiple stakeholders. During the improvement planning process, leaders focus on priority needs, funding, and closing achievement gaps between identified subgroups of students. We also have some changes to goals based on the fact that our school has merged with another elementary school in our district that was closed and increased our enrollment by 100+ students. An adjustment to assessment score goals was made to reflect that while still attempting to show growth from the

previous school year. Long term goals will be adjusted in the 2022 CSIP to reflect needs of the new student body and staff.

Operational Definitions

Elementary/middle schools must have goals for proficiency, separate academic indicator, achievement gap, growth, and transition readiness. High schools must have goals for proficiency, separate academic indicator, achievement gap, graduation rate, and transition readiness. Objective: Short-term target to be attained by the end of the current academic year. There can be multiple objectives for each goal.
